Shoreline Impact

- Chandeleur Island

- As of 05/16/2010, Houma IC estimates that about 47,000 feet (~ 9 miles) of Louisiana shoreline has been impacted to date. Most of the impact was by "very light" to "light" sheen. Of the 47,000 feet of shoreline impacted, about 2,400 feet of shoreline had cleanable oil.

- Drill rig DD-II is on scene (finished jetting in 36" casing).
- Top Kill: Currently working to attach choke line jumper to BOP
